RE: Increase in Wine Markup and Freight Rate Review (LAFR)

## Wine Markup

On Monday, June 20, 2016, the *ad valorem* markup for wine products will increase two percentage points.

The rates will be adjusted as follows:

Quotes must be emailed to <a href="mailedtopricing@lcbo.com">pricing@lcbo.com</a>. Faxed quotes are no longer accepted.

For import suppliers wishing to maintain a retail price, the signed quotation should clearly state "REBATE", with an indication the supplier agrees to pay to reduce the cost of the inventory on hand and on order. The rebate will be applied to all inventory on hand and on order as of June 20, 2016.

## **Logistics Average Freight Review (LAFR)**

The quarterly review of the LAFR will be complete by Monday, April 4. Suppliers affected by this review will receive notification by this date. Any supplier wishing to adjust their quote as a result of this review must submit revised quotes by Monday, April 25, 2016. New quotes should take into account the freight rate and revised markup rate (if applicable).
