RE: Re: Beer Minimum Retail Price Changes

Dear trade partners,

On August 7th, 2018 the provincial government announced the re-structuring of beer minimum retail prices. Additional information regarding this announcement can be found <u>here</u>. In accordance, the LCBO will be administering all new pricing requests. The new beer minimum retail prices are as follows:

package volume times the alcohol %, plus the environmental levy, plus the HST on the levy, plus an amount equal to 4% on the levy.
